The book focuses on issues arising under the dormant Commerce Clause and other provisions of the U.S. Constitution that limit state taxing powers, including nexus, apportionment, and discrimination. Included are many cases from state courts and a generous sampling of U.S. Supreme Court cases. The sixth edition is totally up-to-date, covering *Amazon.com v. New York*; *Town Fair Tire v. Massachusetts*; *Polar Tankers v. Valdez*; and *Kentucky v. Davis*.
